



ROTHER VALLEY GOLF CENTRE - MEMBERSHIP TERMS AND CONDITIONS

THE FOLLOWING TERMS AND CONDITIONS APPLY TO ALL GOLFING MEMBERS OF ROTHER VALLEY GOLF CENTRE

- 1/ By paying for an annual subscription you are deemed to have done so in full knowledge and acceptance of these terms and conditions and the disciplinary policies and procedures which are available to view on the website.
- 2/ These terms and conditions may be changed at any time and without prior notice. The latest version will be that which is published on the Rother Valley Golf Centre web site (info@rothervalleygolfcentre.co.uk) at any time.
- 3/ Memberships are non-refundable and non-transferable.
- 4/ Applications for membership are approved or otherwise at the sole discretion of RVGC and membership does not commence until an application or renewal has been accepted by RVGC and the appropriate payment is received.
- 5/ Renewal subscription payments are due on the first day of the relevant subscription year. (1st July) If not paid in full on this date the membership is deemed to not be renewed and all membership rights will cease immediately until the renewal payment is made.
- 6/ Subscriptions are payable by cash, cheque or credit/debit cards. No monthly payment option is currently available.
- 7/ Membership is based on a 12 month period and cannot be suspended or terminated for any reason including but not exclusive to the following: illness or injury.
- 8/ Rother Valley Golf Centre will do everything it can to offer a golf course available for play on every day of the year with the exception of Christmas Day. However there will be no subsequent reductions in membership fees or extensions to the membership period if the course is unavailable for play for any reason including, but not exclusive to, course closures for adverse weather, external bookings and large events or health emergencies such as epidemics or pandemics.
- 9/ Rother Valley Golf Centre will do everything possible to make buggies available for those that either want or need them for playing. However there will be times where the course is deemed unfit for buggy use yet still be suitable for walking with trolleys or carrying. There will be no subsequent reductions in membership fees or extensions to the membership period to compensate for any periods where buggies are unavailable.



This will also be the case for any periods where the course is deemed unsuitable for trolley use and only carrying of clubs is permitted.

We will also endeavour to allow the use of members personal, single seater ride on buggies for as much of the year as possible however there may well still be times when the course is deemed unfit for their use, such as if there is a full trolley ban and only carrying is permitted. There may be times where trolleys are permitted but single seat ride on buggies are not allowed. In these instances a review of conditions will be carried out regularly. There will be no subsequent reductions in membership fees or extensions to the membership period to compensate for any periods where this is the case.

10/ Granting of membership entitles you to use the facilities at RVGC for the relevant membership year only, in accordance with the restrictions applicable to your membership category and these terms and conditions.

11/ Granting of membership does not imply an automatic right to renew membership in subsequent years.

12/ We reserve the right to limit the number of members in any given membership category, to amend the allocation of exclusive visitor or member tee times or to close the course at any time. Any such decision will not be made unreasonably but may be made at the sole discretion of RVGC.

13/ Members wishing to use the BRS system for online tee booking must provide us with an email address. This email address will be used to keep you informed of news and events at RVGC in line with Data Protection Laws.

14/ Data Protection. You consent to our use of the information given by you, including your personal information, for the administration of your membership and our marketing purposes. We will not pass on your information to third parties for marketing purposes. We do need to pass on some information about you to England Golf to administer handicaps. This information includes an email address and date of birth.

15/ Player Safety & Weather Conditions. Every player is responsible for their own conduct on the course. Golf is played in many weather conditions and player must be aware of the extra challenges presented e.g reduced visibility in mist and fog, slippery ground conditions during wet and icy weather. Any player playing in such conditions does so at their own risk. Suitable clothing and footwear should be worn at all times.

In the event of thunder and lightning, all players must leave the course immediately.
